Inter Connection Exchange (ICX)

GETCO Telecommunications Limited has been awarded the Interconnection Exchange Operator License No. BTRC/LL/ICX(4)/GETCO/2008-1 Dated: 25.02.2008 by Bangladesh Telecommunication Regulatory Commission (BTRC) in February 2008 to connect all telecom operators of the country. We have installed two (2) exchanges in Dhaka – one is at Kaderia Tower, Mohakhali and the other is at Khawaja Tower, Mohakhali. In addition, there are two Interconnection Exchanges in Bogra and Sylhet from which uninterrupted telecommunication service has been providing to ANS (Access Network Service) & IGW (International Gateway) operators since.

The state-of-the-art equipment Huawei SoftX3000, UMG8900 and High-End network router NE40E and NGN OSN3500 multiplexers having STM-64 backbone have been deployed as core switching and transmission platform in GETCO network. World class billing system on Sun Platform running Oracle Billing and Revenue Management Suite (OBRM), with the present processing capacity 35 million CDR per day which is expandable up to 50 million CDR per day has been deployed.

The system's present capacity is 12 million Busy Hour Call Attempt (BHCA), expandable up to 16 million. Four Media Gateways (MGW) with present trunk facility 150 STM-1 are installed in GETCO ICX network, expandable 178 STM-1. It can handle 150,000 concurrent calls and is fully redundant with backbone transmission network as well. All telecom operators of the country in those zones are connected with GETCO ICX to send and receive their inter operator calls both national and international.

Yearly turnover of GETCO ICX is approximately USD 5.5 Million.

GREENTEX COMPOSITE MILLS LTD.

Greentex Composite Mills Ltd. is a textile manufacturing unit of GETCO Group. The unit was established in 2016 and went into production from September 2019. It produces 100% export quality yarns catering to leading export-oriented knitwear manufacturing companies.

The factory is located beside Dhaka-Tangail Highway in Mirzapur, Tangail which is around 60 km from the capital city. The main factory building is comprised of 140,000 sq. ft area with a raw cotton warehouse of 30,000 sq. ft and finished yarn warehouse of 20,000 sq. ft.

The factory produces high quality yarn by using mostly European equipment and by employing high priced trained employees. As such the product is sold at a premium price.

The factory has its own natural gas based Captive Power Generation plant which produces 4.5 MW of uninterrupted electricity.

The annual sales of the company is around USD 30 million. The unit currently employs 900 people.

Business Focus: Supply different types of quality yarn to the leading export-oriented textile manufacturers.

GETCO AGRO VISION LIMITED (GAVL) was launched in the year 2006 with a vision to contribute to national food security and food production of the country and upgrade the farmers' income by providing quality seeds of high yielding variety as well as keeping track with global seed market.

Our objective is not only to produce, process and supply of quality seeds for farmers' highest level of satisfaction, but also to develop and disseminate the appropriate technologies of successful crop production, which is one of our corner stones in our mission. In order to achieve this objective, we have our own R&D Centers in the country where regular research is conducted.

Research and Development:

Realizing the importance of research, GETCO Agro Vision Limited has put its intensive focus on R&D by establishing three R&Ds at Trishal (Mymensing), Bogra and Atwary (Panchagarh). A dedicated team with strong research background has been working from the inception of the company. There are two basic wings of crop research: **1) Rice breeding** and **2) Vegetable breeding**.

- 1) **Rice breeding**: Our breeders have already developed a few excellent varieties which are now being multiplied for marketing.
- 2) Vegetable breeding: Currently we are handling 27 vegetable crops including papaya and water melon. Main focuses for hybrid development are for all types of cucurbit crops, tomato, eggplant, chili, radish, okra, etc. It is citable that we have developed CMS hybrid of Radish and Chili.

Present R & D resources:

- a) Established a 14 acres at Atwary (Panchagarh) and 10 acres at Bogra with all necessary facilities.
- b) Established one secured gene bank at Bogra where more than 8000 valuable germplasms of different crops are preserved.

Production:

This company deals with the production of OP and hybrid varieties of cereals and vegetable seeds.
